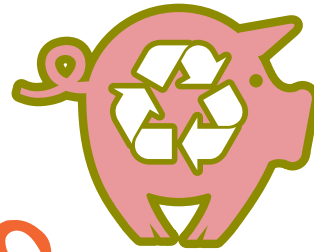

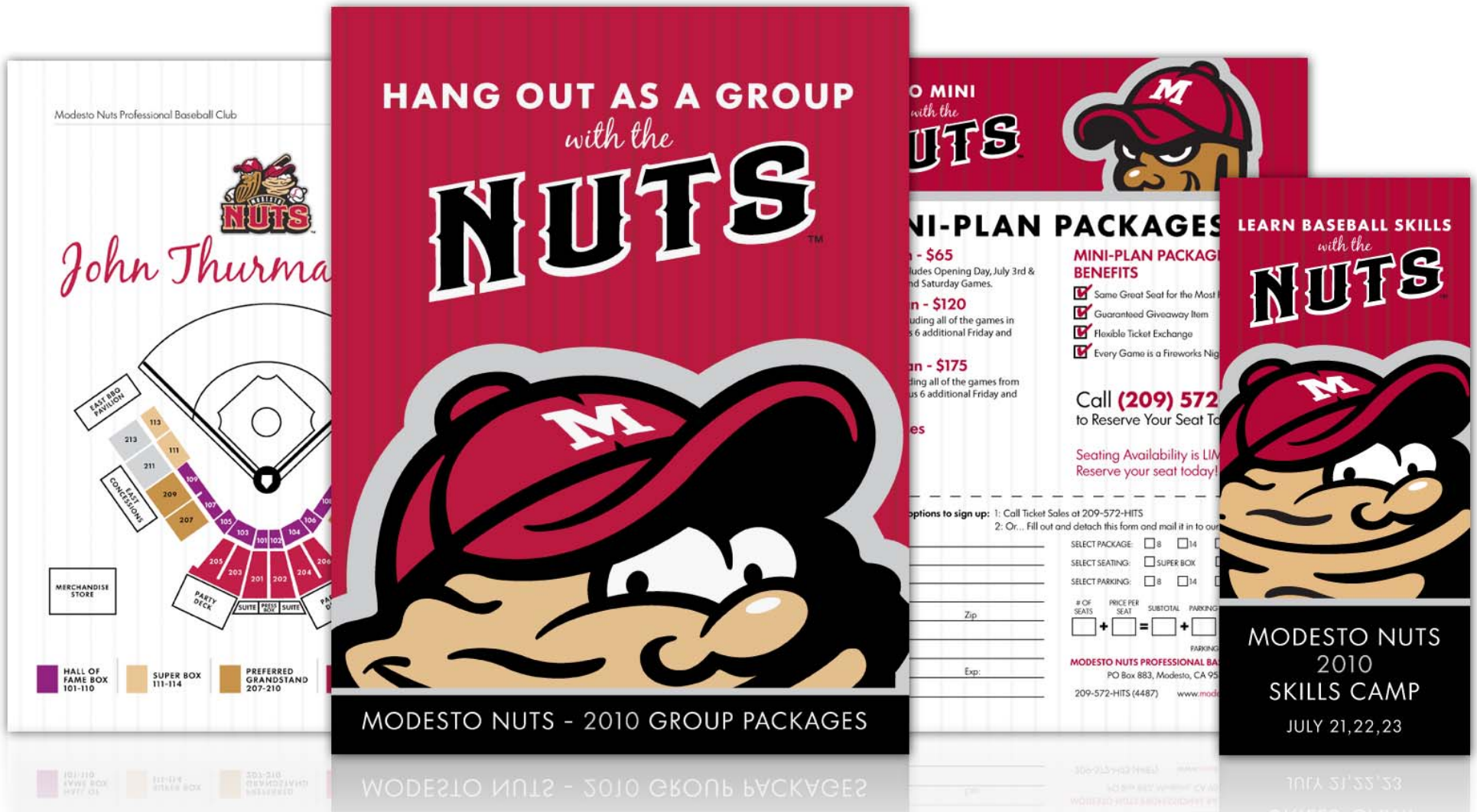

Modesto Nuts Professional Baseball Club

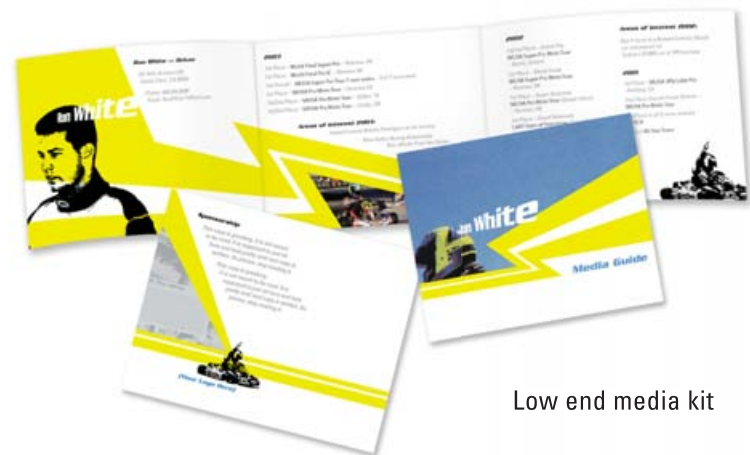

High end media kit

Ron White - Race Car Driver - Media Kits

Race car driver Ron White was looking for ways to help him get sponsorship and make a move into the Formula One scene. We designed him two different media guides. One high end guide, featuring picture and information cards held in a rubber covered portfolio. These were designed to send out to major prospects and the media. We also designed a lower end, folded brochure, which contained all the same information. Being cheaper to print, these could be sent out to a much wider audience.

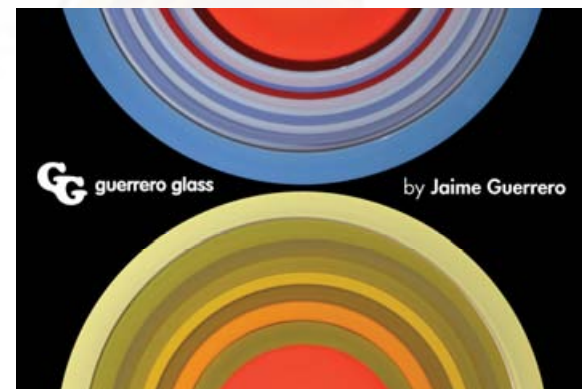

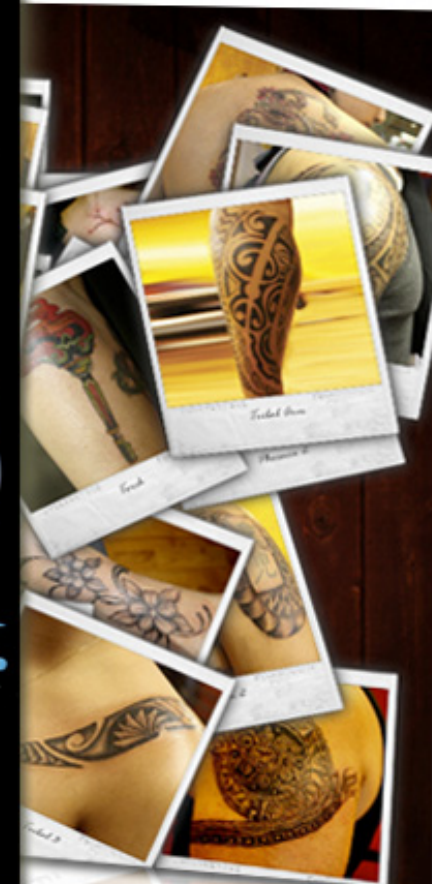
